



- iii) The Executive body will meet once in a month or earlier if there is need for it.
- 7. QUORUM

The quorum for both General Body and Executive Body shall be 2/3rds(two thirds) present and voting.

- 8. Duties of office bearers:
 - i) Prosident: The President shall preside over all the meetings of the General body Governing body and sub committee. He shall have the right to call for emergency meeting for transaction of the urgent matters if any. He shall be in over all control of the society and its working.
 - ii) Vice President: In the absence of Chairman, he shall perform the functions of the Chairman.
